Please read these General Conditions of Sale carefully before proceeding with the purchase. Completing any purchase you fully accept these General Sale's Conditions, as they can be changed at any time.

The following general terms and conditions of sale apply to all sales contracts between Pedersoli Davide & C. Snc, a company established and regulated by the Italian laws with offices in Via Artigiani, 57, Gardone Val Trompia, Brescia, VAT number 00588030981 Fiscal Code 00919300178, which manages this website and the customer whose residence can be in any Country where this website is or will be active.

## Orders

Davide Pedersoli & C. Snc delivers the purchased products to the address indicated by the Customer, within 10 working days from the date of the order.

For all orders placed on the website **shop.davide-pedersoli.com** or **catalogue.davidepedersoli.com** an e-mail will be sent to confirm the order to the address indicated by the customer in his data sheet.

Davide Pedersoli & C. Snc may, at its discretion, refuse an order, or decide whether to accept in whole or partially any changes requested by the customer, provided that such requests are received by Davide Pedersoli & C. Snc before the packaging of the selected items is made.

If one or more items in the customer's order are not available, Davide Pedersoli & C. Snc will have any supply obligation; in this event Davide Pedersoli & C. Snc will inform the

Customer of the non-availability of the ordered item and any amount will be charged concerning the non-deliverable item.

Davide Pedersoli & C. Snc reserves the unquestionable right to hold the shipment of the goods, whereas the customer has not regularly paid the whole required amount or there are legal actions in progress concerning that order.

## Invoice

Whatever the order and payment method, the customer will receive the invoice attached to the package from Davide Pedersoli & C. Snc while a copy of the same invoice will be kept in the files. The invoice will report the information provided by the customer. Davide Pedersoli & C. Snc advises the customer to always check carefully the accuracy of the information provided.

## Delivery

The product is delivered by definition to the shipping address indicated on the order's form. In the event the delivery address is different from the billing address, the Customer is required to clearly state the two different addresses on the order form, to avoid mistakes in the delivery of the goods.

Should the order includes guns, the shipment address must be the one of the chosen pick-up point (gun-shop).

Should delays occur in the delivery due to causes beyond the reasonable control of Davide Pedersoli & C. Snc, the Customer will be notified in writing.

For the catalogue order placed on the **catalogue.davidepedersoli.com** website, the delivery and billing address will be considered the same; unless the customer sends a request about the change of the billing address to [shop@davidepedersoli.com](mailto:shop@davidepedersoli.com).

## Right of withdrawal

The buyer is required to check the weight and package contents upon arrival. After 14 days from the collection of the goods by the recipient, this is fully accepted. Any complaints concerning the types and quantities supplied and objective defects, therefore, under penalty of forfeiture, must be reported in writing within 14 days from the delivery.

In case of faulty product received by the Customer, it can be returned to Davide Pedersoli & C. Snc within 14 days from the date of receipt. It must be returned in its original package and complete with all the accessories that might have been included in the package. The product can be replaced or refunded. In case of reimbursement, the refunded amount will



be that of the product only, with the exclusion of any packing, shipping and insurance costs.

Return shipping costs are totally at the expense of the buyer. Davide Pedersoli & C. Snc recommends an insured shipment, as the return goods is under the full responsibility of the purchaser. Damaged items due to incorrect use of the customer will not be reimbursed.

The buyer has the right to withdraw from the sales contract without explanation and without penalty.

To apply the right of withdrawal, the Customer must inform Davide Pedersoli & C. Snc. of the decision to withdraw from the contract by an explicit declaration (eg letter sent by registered mail A.R., fax or e-mail) to the following address:

### **Effects of the withdrawal**

In response we will send a confirmation of receipt of the withdrawal on a durable medium (eg via e-mail)

The buyer is asked to return the goods or to deliver them directly to Davide Pedersoli & C. Snc located in Gardone V.T. (BS) via Artigiani, 57 without delay and within 14 (fourteen) days from the day we send confirmation of receipt of the withdrawal from this contract. The deadline is met when the goods are returned before the expiry of the period of 14 (fourteen) days.

Should the buyer withdraw from the contract, all payments made to Davide Pedersoli & C. Snc will be reimbursed, including delivery costs (with the exception of additional costs resulting from your choice of a type of delivery other than the less expensive standard delivery offered), without undue delay and in any case no later than 14 (fourteen) days from the day of receipt of the goods. The refunds will be made using the same payment

The shipping costs to Davide Pedersoli & C. Snc are to be paid by the Purchaser.
